Benefits You Can't Outlive—Charitable Gift Annuities

Girls Scouts San Diego is now able to offer charitable gift annuities through The San Diego Foundation as our partner in philanthropy. This opportunity is ideal for donors interested in making a gift that provides lifetime income to themselves or other loved ones. Charitable gift annuities have been in existence for over 160 years and are one of the most

popular gifting vehicles in America today. A minimum contribution of \$25,000 is all that is needed to establish this arrangement for the benefit of Girl Scouts.

Gift annuities are a great tool to sensibly increase income and reduce taxes, while ultimately helping to support Girl Scout programs and services. This simple combination of financial stewardship and smart tax planning can provide you with an easy way to increase your lifetime income without exposure to stock market volatility and/or declining interest rates. Gift annuity contracts are easy to facilitate and don't require changes to your trust or estate plan.

In addition to attractive, fixed payments, based on age at the time of the gift, gift annuities provide donors with a substantial income tax deduction. Part of the annual income will also be exempt from income tax. For example, the current, guaranteed rate of return for a single person, age 75, is 6.5%. Because of the tax benefits associated with this arrangement, the effective rate of return for a single donor, age 75, (28% tax bracket) is 9.44%

Charitable gift annuities are also flexible. You can choose to receive payments monthly, quarterly, semiannually, or annually. Gift annuities can be established for you, for you and your spouse, or for one or two other people, such as a child or other loved one.

If you hold low or non-income-generating securities or even real estate and want to increase your annual income, a charitable gift annuity may be ideal.

Donations using appreciated property have the added benefit of avoiding significant capital gains tax that might otherwise be due if you sold the property. Payments cannot be lowered, canceled, delayed, or suspended, regardless of the stock market or the national economy. Your rate of payment on a particular gift annuity agreement will never change. It's easy to understand why gift annuities are so popular.

Tange reconnected with Girls Scouts after working on her estate plan and becoming a Legacy Circle member 6 years ago. Girls Scouts held a special place in her heart and she chose to demonstrate her support for future generations of girls by making a bequest to Girl Scouts San Diego.

"Girl Scouts represents wonderful people, positive experiences, and great relationships," says Tange. Her mother, GracielleTipton, was a troop leader. A young Tange enjoyed many Scouting activities including campouts, cookie sales and special projects for much sought-after badges. Cookie sales involved the entire family (including Dad, Harold Tipton) loading up the station wagon and selling cookies (only 50 cents a box at the time!) at locations all over San Diego.

Tange particularly enjoys volunteering for the Council's annual fund raiser, Urban Campout. She has served on the event's organizing committee for five years. Tange is also a member of the 100th Anniversary Committee where she serves on the alumni subcommittee, recently participated in the Girl Scout's Leading the Way conference held in San Diego, and has also served on the Audit Committee. In June, she had a terrific time accompanying a girlfriend's troop of five to nine year-olds to Camp Winacka in Julian.

Charitable Giving With Your IRA

If you are like many, your IRA has increased in value over the years and you may have more income than you need. The IRA rollover gift, still available through the end of 2011, is a simple and easy way if you are over age 70 ½ to make a gift while not increasing your taxable income. This tax-free rollover gift can be any amount up to \$100,000, and can also be used to satisfy your required minimum distribution for this year. Simply contact your IRA custodian for instructions and forms to make the gift.

Future IRA Gift Options

While you may have the opportunity to give through your IRA now, there are other options available for making future gifts from your individual retirement account to us.

One option is to designate Girls Scouts San Diego as the beneficiary of your IRA. This permits you to continue to take withdrawals from your IRA during life and then leave the remaining value of your IRA to Girl Scouts. Since there is no income due on amounts left to a qualified charity, this is an excellent asset to use for this purpose.


Another option is to make a future gift of your IRA to charity while providing income to your heirs. This can be done by setting up a testamentary IRA gift annuity or testamentary IRA unitrust in your estate plan. An IRA Gift Annuity will provide income to heirs for life. An IRA unitrust, sometimes referred to as the "Give It Twice" trust, usually provides income to children for a period of up to 20 years. After that time, the trust passes to a designated charitable beneficiary such as Girl Scouts San Diego, creating a wonderful way for you to leave a legacy.
