# The Cushman Family: Girl Scouts for Life

For the Cushman family, Girl Scouting is a way of life that spans five generations. It all started with Grandmother M. Louise Miller, who co-led the troop of her Girl Scout daughter, Marjorie. Continuing this tradition, Marjorie and her husband, Stephen Cushman, raised two Girl Scout daughters, the now-grown Debby Parrish and Lori Moore. Debby was the troop leader for her own daughter, Britny, and Lori did the same for her daughter, Keely. Later, Britny's brother Nikolas married a Girl Scout alumna, Kristen. The Cushman family also has a future Girl Scout in the wings: Charli, the 11-month-old daughter of Britny and her husband, Tony Camacho.

Girl Scouting has long been a staple in the Cushman family culture. Debby and Lori were Girl Scout Cookie entrepreneurs under their mother's troop leadership, and wanting a constructive and uplifting environment for her daughter, Debby led Britny's troop for 13 years. Debby recalls, "It was the first experience she had in community service. She learned early how to give back and help others."

Debby has continued to proudly mentor girls in their leadership journeys. She is a champion of the Girl Scout Gold Award, and strives to eliminate road blocks so more Girl Scouts across our council can earn this prestigious honor. Under Debby's guidance, the girls in her troop and many others in her service unit completed Gold Award projects with lasting, positive benefits.

## **The Power of Camperships**

Every summer, Girl Scout camps are bustling with girls ready to embark on adventures and try new things. Robot-building, canoeing, adventure courses, hiking, archery, and coding are examples of what Girl Scout campers experience—some for the first time. Through activities like these, girls overcome fears and take risks. They are challenged and build resilience. Campers learn to love the outdoors and become caretakers of our environment.

• amp is a transformative experience where, within days, girls build their leadership skills. This year, 3,870 girls attended Girl Scout camp and grew from that experience. Because of the generosity of our donors, along with Girl Scouts who donated their cookie rewards to help fund "camperships," 446 girls were able to go to camp. Just imagine: 446 girls would have missed out on spending a night away from home, riding a horse, experimenting with science, making new friends, building confidence in a theatre production, or testing themselves on the High Ropes Challenge Course.

In some cases, these adventure camp experiences allowed girls to take a break from hardships and simply have fun! Thanks to you, girls from foster care, homeless shelters, lowincome families, or with special needs, went to camp this summer.

**G** irl Scouts San Diego's actual cost to run camps averages \$2,000-5,000 per girl per session. However, through support from donors, we are able to subsidize our camps to ensure more girls can have outdoor adventures, which keeps camp available to girls for \$100-500 per session. Additionally, more than two-thirds of campers benefited from reduced fees, which made the fun and adventure of Girl Scout camp affordable and accessible, regardless of family circumstances.

## Ten Tips for Financially Savvy Women

During our Volunteer Conference in August, our What Every Financially Savvy Woman Should Know workshop panelists shared actionable steps on how to plan for the future:

- Select a trusted attorney and financial advisor or accountant.
- 2. Avoid the courts and the IRS whenever possible. If you have more than \$150,000 in assets (without a beneficiary designation), you should have a trust to keep your estate out of probate following your death.
- 3. Select guardians to care for your minor children in case you die unexpectedly. Create a letter of intent so the guardians understand your wishes.
- 4. Review successor trustee and agents every few years.
- 5. Check your beneficiary designations.
- 6. If you have a child with special needs, create a special needs trust.
- 7. Communicate with your adult children regarding who your financial professionals are, and share your estate planning documents.
- 8. Consider a 529 plan, which is an excellent way for parents and grandparents to save money for children's educations.
- 9. Make sure your parents' estate is in order. Talk to them sooner rather than later about their wishes for when they can no longer take care of themselves. Go to the bank with them. Research assisted living options, and agree on where they will live later in life. Simplify your parents' finances and confirm so there are no misunderstandings.

## Seven Things You Need to Know About the New Tax Law

You may be wondering how the introduction of the new tax law this year may impact you. For many taxpayers, the lower tax rates create an opportunity in the form of increased disposable income.

Following are the main takeaways of the new law, along with some things to consider for tax readiness and charitable giving.

#### What's different?

#### **Income tax brackets**

Whether you're a single filer or a married person who files jointly or as head of household, your tax bracket will be new in 2018.

The new law maintains the seven existing tax brackets, but lowers rates for most brackets (to 10, 12, 22, 24, 32, 35, and 37 percent). Most taxpayers will see their tax rate decrease. A single person with an income of \$70,000, for example, will go from a 25 percent tax rate to 22 percent under the new law.

As a result of these changes, you may now have an opportunity to give to the charitable organizations you care about, such as Girl Scouts San Diego.

#### **Higher standard deductions**

The standard deduction is nearly doubled to \$12,000 for single filers, \$18,000 for heads of household, and \$24,000 for joint filers. You may be less likely to itemize on your taxes and use the income tax charitable deduction. The increased deductions provide an incentive to give more to charity in one particular year over another to exceed the standard deduction and be able to itemize.

#### **Itemize deductions**

If you elect to itemize this year, your deductions may look a little different (though charitable deductions remain under the new law). Under the new plan, you will be able to deduct up to a total of \$10,000 for state and local taxes. If you purchase a new home, there is now a cap on the mortgage interest deduction for the first \$750,000 of debt on a newly purchased home.

#### Charitable contributions for cash gifts

The new law increases the current limitation of 50 percent of your adjusted gross income for donations by cash, check, or credit card up to 60 percent. Higher net worth donors may want to consider increasing cash gifts.

#### What's the same?

#### **Charitable deductions**

You will still be able to deduct your charitable contributions if you itemize your taxes.

#### Long-term capital gains and dividends

The tax rates on capital gains and dividends remain the same (at 0, 15, and 20 percent, depending on your tax bracket).

#### **Charitable contributions of appreciated property**

The limitation on charitable gifts of long-term appreciated property to public charities will remain at 30 percent of your adjusted gross income. You can still carry over any excess for up to five additional years.

### Camp Exec Mentors Open Doors to Girls' Futures

During our third annual Camp Exec, 34 Girl Scouts in grades 10-12 spent a weekend at Camp Whispering Oaks learning about career success and leadership development from 20 high-achieving professional women. Mentors included San Diego Superior Court Judge Sharon Kalemkiarian (pictured, below right). She was introduced to the opportunity by Kathryn Ashworth (below center), a Girl Scouts San Diego Cool Woman of 2013 and Camp Exec mentor.

The program addressed topics like social and business etiquette, projecting a positive image, developing a personal brand, and networking strategies—as taught by the pros! Grouped into "squads" based on strengths and interests, girls and mentors shared dreams, life lessons, and how to turn challenges into opportunities. Campers also explored the High Ropes Challenge Course, tried their hands at catch-andrelease fishing, and practiced archery.

#### **Balance Your Giving**

Because life is unpredictable and the value of your assets may rise and fall, donating a percentage of your estate to Girl Scouts San Diego is a smart way to help us forward our mission while ensuring your dependents still get what they need.

This is a solution that allows you to recognize more than one person or charity that has been important in your life. Gifts to loved ones and to organizations such as Girl Scouts San Diego remain proportional, no matter how your estate fluctuates, and you can change your mind at any time.

#### Here are a few different ways to make sure the people and causes you support are protected after your lifetime:

- 1. Leave a percentage—from 1 to 100 percent—of the assets in your will or trust to support our work.
- 2. Allocate a percentage of your residual estate, which is the portion of your estate that remains after all other gifts have been made and all claims against the estate are satisfied.
- 3. Name Girl Scouts San Diego as a beneficiary of a percentage of your life insurance policy or retirement plan account.
- Designate Girl Scouts San Diego to benefit from a percentage of your remaining bank account or brokerage assets.\*
